Faster E-Bulk Submission

Applications submitted by EasyDBS use the Disclosure & Barring Service's electronic submission service, known as E-Bulk. This allows us to ensure that each application is accurate and significantly reduces processing time.

Client Account User Management

The EasyDBS platform has been developed for both large organisations with multiple locations and small single site organisations. Features such as multi-user access, restricted level access, departments and central finance mean that EasyDSB is scalable with your organisation.

Comprehensive Payment Options

CREATE APPLICANT

Creating your applicants is the first step. You will simply log in to the Application Management system using your unique login credentials and navigate to the 'Create Applicants' menu option. Here you will enter the applicant's name and email address. Your applicants will then receive their unique application login details by email



APPLICANT COMPLETES FORM

The Application Form is divided into 4 easy to complete sections. Each section uses validation rules. This ensures that the information provided is accurate and free from errors prior to being submitted for processing. This way we help to ensure applications are not returned or rejected by The Disclosure & Barring Service



CONFIRM APPLICANTS IDENTITY

This step requires your applicant to present themselves to you with their identity documents. Each document must be selected in the Application Management System. Once the correct number and combination of documents have been entered, you will be able to submit the application for processing



VERIFY AND SUBMIT APPLICATION

Once the applicant's identity has been confirmed you will be able to select the options for the application such as Standard or Enhanced, with or without Barring List Checks. You will then be given a final summary of the application before submission for processing.



PAYMENT

EasyDBS offer BACs Bank transfer, online Card Payment or Paypal. You may also make use of our credits system whereby applications are bulk purchased in advance allowing team members to use these credits when they require without having to request payment of invoices from central finance teams.



APPLICATION STATUS UPDATES

EasyDBS will keep you and your applicants informed on the status of applications as they complete each stage of processing. Once an application has been fully processed you will receive an email advising you that a results snapshot has been made available within your applicant management area. Applicants will receive their certificates to their current registered address.

WHICH DBS CHECK IS RIGHT FOR YOUR APPLICANTS?

Easy DBS offer the three main types of DBS Application, Standard, Enhanced and Volunteer. Only organisations can request these types of DBS Application on behalf of an employee or volunteer. Legislation in England and Wales currently does not allow indviduals or self employed persons to apply for themselves.

Standard Applications

A Standard DBS Application will check the applicant for any spent or unspent convictions, cautions, final warnings or reprimands. In order that the applicant is eligible for a Standard DBS they must be undertaking a role as listed in the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975. Included in this list are a number of postions covering a variety of professions and licenced activities. For further information we always advise checking the DBS Website for further information.

Enhanced Applications

An Enhanced DBS Application will check the applicant for any spent or unspent convictions, cautions, final warnings or reprimands along with any relevant details held by the applicants local police authorities. An Enhanced Application may also include a check of the Child and/or Adult Barring List subject to the applicant's position being eligible. In order that the applicant is eligible for a Enhanced DBS they must be undertaking a role as listed in the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 and Police Act 1997 (Criminal Records) Regulation. Included in this list are a number of postions covering a variety of professions and licenced activities. For further information we always advice checking the DBS Website for further information.

Volunteer Applications

A Volunteer Application can be either a Standard or Enhanced Check for a person as defined by the Police Act 1997 (Criminal Records) Regulations 2002 as being engaged in unpaid activites, (other than expenses), which aims to benefit a third party other than a close relative. Volunteers must not be on a trainee position that will lead to full time paid employment and must not receive payment for their work. Should a volunteer later become a paid member of staff, a new application is usually requested.
